# Good Practice Forum for Residential Provision for Children with Complex Needs

1<sup>st</sup> meeting - 5 March 2024

## Progress to date

At end of 2023 across Wales, there were 36 residential provisions supporting 76 children with complex needs.

Diverse provision on offer:

- Residential care with therapeutic service for short term placements
- Residential solo placements
- Emergency accommodation
- Psychological assessment and intervention
- Supported lodgings for young people
- Short-breaks service
- Child and family In-house residential

Residential provisions on the horizon:

- 11 new provisions are expected to complete works by the end of March 2024, this will provide 42 beds
- 9 new provisions starting work in 2024/25, providing 35 beds
- 24 new schemes in design or planning stage, with an estimate of 86 beds

But it is simplistic to look at this work just through numbers.

# Definition of Residential Provision for Children with Complex Needs

- **Complex needs** is defined as severe emotional, behavioural and mental health needs requiring specialist, multiagency care and support in a home setting which is jointly commissioned by the Regional Partnership Board statutory partners.
- Residential provision is a **step-down provision** intended to prevent escalation to and facilitate de-escalation from secure welfare and tier 4 mental health inpatient provision; it can also help with avoiding placements out of county or out of Wales due to lack of provision locally.

## Discussion points:

2. Is having an agreed definition helpful for this group?
3. Is the definition clear and comprehensive – anything needs clarifying or is missing?
4. Does the definition restrict the development of the provision?

For people involved in developing residential provision for children and young people with complex needs, aiming to:

- Contribute to a **good practice toolkit** for the development of residential provision for children with complex needs.
- Promote productive discussion and encourage **collaborative solutions** in for example project and programme management.
- **Showcase achievements**, share lessons learnt/pitfalls across projects and how to overcome common challenges.
- Understand the **circumstances** that allow for **good practice to flourish**.
- Identify **barriers** that exist to adoption of innovative ways of working and support, including local service integration for example with education and health.
