

Introduction

The Impact risk assessment is completed by the Registered Manager (or Deputy Manager) in consultation with the staff team. It is based on all information available from such sources as Social Workers, Foster Carers, Education Staff, CAMHS Team and information contained in the Residential Referral Document.

The purpose of the Impact risk assessment is to assess the suitability of the young person including the impact that he/she/they will have on the group currently present, and the local community.

The impact assessment will assist in determining whether or not Y Dderwen is an appropriate placement for the young person i.e. if he/she/they will be appropriately placed within the current group of young people already resident. The document will also assist in determining whether additional resources or staffing are required in order to safely accommodate the young person.
